

Grand Port/Savanne District Council (Fees for Classified Trades) Regulations 2006

GN No. 172 of 2006

THE LOCAL GOVERNMENT ACT 2003

Regulations made by the Grand Port/Savanne District Council under sections 102(1)(a), (3) and (4) of the Local Government Act 2003

1. These regulations may be cited as the **Grand Port/Savanne District Council (Fees for Classified Trades) Regulations 2006**.
2. The fees specified in the second column of the Schedule shall be levied in respect of the corresponding classified trades specified in the first column of that Schedule.
3. The Grand Port/Savanne District Council (payment for fees, dues or other charges) Regulations 2005 (GN. No. 103 of 2005) are revoked.
4. These regulations shall be deemed to have come into operation on 1 October 2006.
